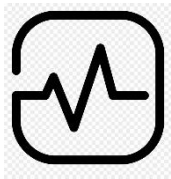

The CSG [STATE RECOVERY RESOURCE CENTER](#) provides ongoing analysis of the American Rescue Plan (ARP) Act of 2021, which has an impact on states, both in their budgets and in the specific policies that they enact. The Center also provides other resources that state leaders can use to inform state economic and civic recovery.



The [BOOK OF THE STATES](#) is a state government encyclopedia featuring easy-to-read summaries, tables, and charts which serves as an invaluable reference tool that has withstood the test of time.



The [COVID19 RESOURCES FOR STATE LEADERS SITE](#) provides up-to-date information on the impacts and responses by states to the COVID19 pandemic. This includes a compilation of state executive orders, reopening plans, date and prediction models, vaccination plans, and other resources.



The [CENTER OF INNOVATION](#) provides objective, in-depth analysis and technical assistance on key issues facing the states, including occupational licensing, workforce development, election policy, and health and human services policy.



The [STATE AND LOCAL LEGAL CENTER](#) is a resource to state and local governments on the U.S. Supreme Court. Among other things, it files amicus curiae briefs in support of state and local governments in the U.S. Supreme Court. CSG is a member of the State and Local Legal Center.



The [NATIONAL CENTER FOR INTERSTATE COMPACTS](#) assists states in developing interstate compacts, promoting multi-state problem solving. Search the more than 200 different interstate compacts in effect today by state, name, or year.



The [JUSTICE CENTER](#) serves to promote effective, data-driven practices and solutions where the criminal justice system intersects with other disciplines such as public health and education.
