Therefore, the National Institute of Immigration has a presence throughout the state of Baja California for the provision of institutional services:







#### POINTS OF ENTRY TO THE COUNTRY





The immigration officer is entitled to request various conditions for entry, such as proving his identity, reason for travel, place of habitual residence or provenance, address and length of stay in the national territory.

The procedure at these check points in order to authorize the internment of foreigners, consists of the interview of the immigration authority as well as the review of the documents.

#### **E-GATES**






- ✓ We have been working with the airport staff on the project of installation of e-gates

### HUMAN REPATRIATION PROGRAM







Baja California has 2 reception points for nationals, located in:

«El Chaparral» In Tijuana, and «Mexicali Garita Uno»

Its objective is to achieve the reintegration of the repatriated Mexican population, through coordination with the three levels of government, civil society and private initiative, attending to their return in a safe and orderly manner.





#### LIAISON AND COORDINATION

There are several functions carried out here, and to this purpose, mechanisms are established for liaison and coordination with public, social and private institutions for the development of the actions of the program in order to ensure that the entry of repatriated nationals is carried out with absolute guarantee of their rights and are referred to the competent organisms.




### **ORIENTATION TO MIGRANTS**

They inform of the risks the migrants may face during their trip as well as the rights they have in Mexico to prevent abuses against them.






### U.S. ALIENS WITH ARREST WARRANTS










37.1% of American foreigners housed in the immigration centers in Baja California during 2022, had an arrest warrant for crimes committed, such as homicide, robbery, drug trafficking, sex crimes, human trafficking, among others.
